Mother Incarcerated after Forcing Daughter to Falsely Accuse Father of Sexual Abuse

Litigators Leslie P. Poole and Misty I. Gamino from the Law Offices of Jeffery M. Leving won an important victory in Chicago and finally brought justice to a father by persuading the Judge to incarcerate his ex-wife for violating an order prohibiting her to contact her daughter, and for owing over \$50,000.00 in past-due child support. This occurred after the mother brainwashed her daughter to make false allegations of sexual abuse against her own father.

The father was granted residential custody of their daughter in his divorce. In an attempt to gain leverage in her pursuit to change custody and terminate her child support obligation, the ex-wife forced their daughter to make false allegations of sexual and physical abuse against her father to the Department of Children and Family Services (DCFS).

The ex-wife's malicious attempt to interfere with the father's relationship with his daughter failed when he turned to the Law Offices of Jeffery M.
